Client Agreement

1. I understand that I am solely responsible for all harm and damages caused by my dog(s) while he/she is attending day care, classes, or any other services provided by Dog Days Doggie Day Care, LLC.
2. I agree to inform Dog Days Doggie Day Care, LLC of all risks associated with my dog that are known to me, or that should be known to me, whether or not such risks are specifically asked about on the *Application and Pet Personality Profile*. If I fail to inform Dog Days Doggie Day Care, LLC of such risks, I understand that I am Responsible for all losses or damages caused by my failure to properly inform Dog Days Doggie Day Care, LLC.
3. I shall indemnify and hold harmless Dog Days Doggie Day Care, LLC against any all claims, demands, damages, and costs, including attorney's fees, made against it based on injury or damages caused by my dog while in the care of Dog Days Doggie Day Care, LLC.
4. I further agree to indemnify and hold harmless Dog Days Doggie Day Care, LLC from damages and injury caused to myself, or others that accompany me into Dog Days Doggie Day Care premises, provided reasonable care and precautions are taken by Dogs Days Doggie Day Care, LLC. I agree not to leave children unattended at Dog Days Doggie Day Care, LLC.
5. I hereby release Dog Days Doggie Day Care, LLC from any liability, claims, demands, damages, and costs, including attorney's fees, of any kind, known or unknown, arising from my dog's attendance and participation at the daycare, overnight care, classes or other services.
6. I further understand and agree that any problem that develops with my dog(s) will be treated as deemed best by Dog Days Doggie Day Care, LLC staff in their sole discretion, and I assume full financial responsibility for any and all expenses involved. I recognize and understand that if my dog(s) become ill, or if the state of the dog's health otherwise requires professional attention, Dog Days Doggie Day Care, LLC, at its sole discretion, may engage the services of any veterinarian of Dog Days Doggie Day Care, LLC's choice, may administer medicine, and may give other requisite attention to the dog. I thereof shall pay all expenses and I expressly authorize, by signature below, that all such charges for medical services will become my responsibility.
7. I further understand and agree that in admitting my dog(s) to Dog Days Doggie Day Care, LLC, that the facility has relied upon my representation that my dog(s) is/are in good health and have not been ill with any communicable condition in the last 30 days. I further certify that my dog(s) have not harmed nor shown aggressive or threatening behavior towards any person or other dogs.
8. I recognize that there is an inherent risk of illness or injury when dealing with animals, Such risks included but not limited to, illness due to sharing toys or common water bowls, problems resulting from rough play such as soreness or stiffness, ingesting unknown foreign objects, and/or uncontrolled animals outside our facility.
9. I recognize that there is an inherent risk of fighting or disease transmission, resulting in possible injury or death, when commingling dogs from different backgrounds, with different temperaments, different medical and treatment histories, who are owned by different individuals.

I certify that I have read and understand the rules and regulations set forth by Dog Days Doggie Day Care, LLC and have read and understand this agreement. I agree to abide by the rules and regulations and accept all terms, conditions and statements of the agreement.
